# **Education project – Graeme Ellis**

As well as building the hydro scheme the project is gathering and displaying information for general use and for education. A new wide screen TV with the live feed from the HH website and possibly some static display boards will be installed in the Harlaw Visitors Centre.

There is an appetite for visits and information from schools – local and not so local – they want to come and see how the machinery works. Excellent feedback from Deanpark Primary School on their site visit.

The data gathered will be available for research – by schools, uni and PhD level as well as CEC use.

## Community Plans - Keith Taylor - BVT chair

BVT came out of the BCC and in turn HH came out of the BVT, forming from the original Energy group.

BVT activities have included: Bees, partnering village screen, farmers market – very much a hub where people can come to get support for various village projects e.g. procuring a lease for the janitor's house to help solve the storage situation for the local Scouts. Also using the janitor's house as a community base, particularly with educational links with BHS in mind.

Community consultation – survey monkey. Seeking funding to have a non-paper based consultation element. Asking our community what it wants will always be our starting point.

Currently have funding from DTAS (Development Trust Association for Scotland) for staff – p/t manager, admin and communication to develop BVT as a community anchor organisation.



Get the funding scheme for the use of the HH money is paramount: visit to Udny Community Dev Trust, Aberdeenshire to look at how their grant scheme was set up and how transparent and fair it is. Emma Galloway, VC of BVT. Talking to Foundation Scotland for advice. Aim: 1. how to develop BVT and it's projects (in line with the community consultation) and 2.how to build the capacity of other local organisations.

#### **SEIS**

- The society submitted an SEIS1 (November 2014)
  - o 70 per cent of the first £150k spent
- HMRC returned (SEIS3s) for the society to send to the investors so they can claim tax relief (December 2014)
- Some experiences
  - o HMRC response very slow, don't reply to letters
  - o 30% refund sent
  - Self Assessment form demanded
  - 50% received
- Opinion many tax officers have not come across EIS and even fewer have met SEIS. Persistence may be required.
- Using the SEIS3 supplied by the company the investor claims for the tax year in which the shares were issued (i.e. 2013/2014)
- Investors can claim relief up to five years after the 31 January following the tax year in which the investment was made.

#### **EIS**

- The company must submit form EIS1 to the SCEC
  - The company cannot submit an EIS1 until it has been trading for at least four months (confirmed using form EIS2).
  - EIS1 submission expected December 2015
- If the SCEC accepts that the company, its activities, and the shares all meet the requirements of the scheme, it will issue the company with a certificate to that effect, and will supply claim forms (EIS3s)
- The company issues EIS3s to qualifying Investors.
- Using the EIS3 supplied by the company the investor claims on their Self Assessment tax return for the tax year in which the shares were issued (i.e. 2013/2014)
- Investors can claim relief up to five years after the 31 January following the tax year in which the investment was made.

### **Questions:**

Why SPN and SSE? Normal to have both. One for the line and one for the metre – SSE provide the metre.

What did we pay BT for? We have a telephone line for the broadband for the education web display and to monitor and control the facility remotely.

**VAT?** Yes, we are VAT registered and we do claim the VAT back.

Question about expected and actual operating levels and potential revenue — we can't generate at the optimal level until we get more rain. CEC Flood Prevention use the reservoirs to hold unexpected heavy rain but even allowing for that the reservoirs are unusually low. We are in a very dry period and are operating at lowest level we can with the compensation flow available. The feasibility studies showed the projections based on average rainfall but no-one can predict when and where the rain will come.

We get slightly less income overnight, so if we have to switch off we are doing so during the night.

SEPA requires as a basic minimum a compensation flow coming down Bavelaw Burn, so we are unable to shut off the water completely.

**How often will we get paid from the power company?** – Under our Power Purchase Agreement we are paid monthly for the electricity we export. OfGem pays the Feed in Tariff quarterly and, so we are told, 6 weeks in arears.

**How will the other villages benefit?** The BVT is enabled through it's Memorandum and Articles (Balerno (in Edinburgh) and those communities surrounding the village of Balerno (in Edinburgh). to give money to projects in Balerno and neighbouring communities. The grant scheme will reflect this.
